## CONTEXT

Central African countries regrouped under the Central African Forest Commission (COMIFAC) are actively engaged in the international negotiations for the elaboration of a future post-Kyoto regime 2012. This commitment started in 2005 when the role of tropical forests to combat global climate change was adopted (COP11 Montreal). As such, COMIFAC/CEEAC countries have prepared and submitted their position (views) on the subjects under negotiation in particular avoided deforestation. In accordance with the Bali action plan, pilot projects and initiatives to reduce emissions from deforestation and forest degradation (REDD) have been initiated in the sub-region with support from development partners. The Conference of Parties in Copenhagen offers the opportunity to show ongoing efforts in the Congo basin region to find answers on methodological questions related to REDD.

It is in that context that COMIFAC has organized the current Side Event, with the support of GAF-AG, GTZ, KfW, ESA and facilitated by the CBFP. The Side Event has the objective to share experiences of the current REDD pilot initiatives in the sub-region, and present the opportunities and challenges of implementing the REDD policy process in the Congo Basin.
