The side event builds on the ongoing discussions under the UNFCCC process on the importance of raising awareness on the role of oceans in climate and climate change, and interlinkages and synergies for action.

Specifically, the side event will provide an opportunity to showcase how oceans could play an increased role in providing solutions to the achievement of climate change commitments, including through the effective implementation of ocean-related international instruments. In this context, the event will focus on how ocean-related matters could be further integrated in NDCs and NAPs and how UN-Oceans can optimise support for countries to this end. It will also aim to provide information on ocean-related international regulatory and policy frameworks so as raise awareness of relevant legal instruments and policy outcomes.

The side event also seeks to highlight the UN-Oceans commitment to "deliver as one" on oceans and coastal related issues, including in support of the achievement of both SDG14 and the Paris Agreement.
