## Program COP/MOP Side Event: “The role of JI today and in a post-2012 framework”

This side event will review the current state of play with JI projects around world and look to the mechanisms' evolution in commitment Phase II. JI's flexibility and adaptability make it an essential safety valve to deliver and achieve cost-efficient emission reductions from all GHG sources. To sectors not covered by cap and trade schemes JI offers the ability to incentivize emission reductions, complementing reduction efforts taken in covered sectors and contributing to overall cost-efficiency of the system.

The goal of the Copenhagen round of UNFCCC negotiations is to promote maximum emissions reductions through economy or sector-wide binding commitments to reductions in GHG emissions. The fact that JI per definition operates in capped environments gives it the ability to release the financing for emissions reductions at a scale that is wider and deeper than CDM. Post 2012 JI's geographical coverage will increase considerably in terms of Host Countries and new participants among project developers and investors. Thus it is vital to be ready with a robust project-based mechanism to quickly deploy.
