Responding to climate change is a global challenge with significant implications for small developing countries. Debate on how trade policy can mitigate the effects of climate change has so far centred on developed countries and the large emerging economies, especially China, Brazil and India, but what are the implications for small and vulnerable economies, least developed countries and small island developing states?

These countries are the most vulnerable to the effects of climate change but they are least equipped to deal with changes in trade policy. *Trade, Climate Change and Sustainable Development* examines the opportunities and multiple large-scale challenges they face in adapting key trade sectors to the impact climate change, addressing climate change measures, and furthering their own trade capacity and competitiveness in the global market.

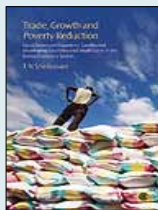
