Exploring Innovative Approaches to Strengthen Capacity on Direct Access to Climate Finance

Venue: Room Bug, 7 December 2018, 15:00-16:30

TLDR: Direct access projects from global funds are scarce. This side event will explore innovative approaches to enhance endogenous capacity and empower developing countries to shift the status quo away from business-as-usual.

Session Description

While climate change mitigation is a global responsibility, adaption is largely local. National and local entities should therefore be best placed to assess local vulnerabilities and devise locally appropriate measures to increase the resilience of vulnerable communities, ecosystems and infrastructure.

Despite a number of national and regional institutions being accredited as Direct Access Entities (DAEs) to the Green Climate Fund (GCF) and National Implementing Entities (NIEs) to the Adaptation Fund, so far there are limited projects approved for direct access by the GCF Board and the Adaptation Fund Board.

In 2016, the Conference of the Parties to the United Nations Framework Convention on Climate Change by its decision 10/CP.22 requested the GCF Board to facilitate an increase in the number of direct access proposals in its pipeline. Intergovernmental organizations and international financial institutions, including those accredited as International Accredited Entities to the GCF and Multilateral Implementing Entities to the Adaptation Fund, are therefore, being encouraged to support the enhancement of the capacity of DAEs and NIEs by transferring knowledge and sharing valuable experiences in developing climate change projects and accessing climate finance.

The objective of this sessions is to identify challenges and barriers impeding the development of direct access adaptation proposals and brainstorm on the approaches to overcome these challenges with support from the international community. The session also offers current experiences and discusses potential opportunities related to climate finance issues in vulnerable countries.
