# Scott Steedman

# During this session:

Scott Steedman will outline the role of international standards as a common, consensus-based approach to enabling change and specifically to accelerating the transition to a net-zero resilient economy. Scott will explain how ISO and BSI will implement the London Declaration, signed in September, by which standards organisations will commit to incorporating climate science in their work on new and existing standards used worldwide and to ensuring that the views of civil society and those most at risk from climate change will be amplified in the process. He will talk about the potential for stakeholder led standards to effect rapid change when used in a coherent way along with regulation and compliance requirements by governments and industry and how the international standards system can become the backbone for national ambitions to reach Net Zero.

# **Biography:**

Scott Steedman is Director-General, Standards at BSI, the national standards body and ISO and IEC member for the United Kingdom. Scott is completing his second term as ISO Vice-President (policy), having served in the role since 2017. A strong advocate for the increased take up of international standards to address global challenges, he has promoted new thinking about the systemic use of standards including regulation to scale change and implement better practices for governments, industry and consumers and as an enabler for innovation, trade and economic growth. He is an Executive Director on the Board of the BSI Group. Prior to joining BSI he held senior roles in the engineering industry, working in civil engineering and infrastructure, in academia and in professional bodies. He was Vice-President Policy of the European Committee for Standardization (CEN) from 2013-16 and is a former Vice President of the Royal Academy of Engineering and of the Institution of Civil Engineers in London.

## Victoria Hurth, Dr

Fellow at Cambridge Institute for Sustainability Leadership (CISL) ISO/TC309/WG1 Guidance for the governance of organizations Co-Convenor

#### During this session:

Victoria Hurth will overview ISO 37000 - the ground-breaking first international consensus-based benchmark for good governance of organizations, regardless of type, sector or location. Victoria will summarise ISO 37000 which was developed by a committee of over 70 countries and 24 liaisons, and its importance for driving organizational response to climate change and unsustainability - including how it marks an important shift in how we understand governance for the 21<sup>st</sup> century.

# Biography:

Victoria works at the intersect of academia and hands-on business to help companies transition to be drivers of long-term wellbeing for all (sustainability). Victoria focuses on five core pillars of organizations: purpose, governance, marketing, leadership and culture. She has 25 years' experience in marketing, management and sustainability, having previously worked for 3M and Accenture with companies including Marks and Spencer and Cancer Research and by developing theory as a full time Associate Professor of Sustainable Business and Marketing. Victoria is currently Technical Author for the first national standard specifying the Worldviews, Principles and Behaviours of Purpose-Driven Organisations (PAS 808). From 2016-2021 Victoria co-led the process to create the first global ISO standard in Governance of Organizations (ISO37000) and currently co-leads the ISO working group (TC309/WG1) developing standards on Indicators of Effective Governance (ISO37006) and guidance for governing bodies in Selecting, Creating and Using Indicators (ISO37005).

Victoria is an UNCTAD review panel member for <u>ISAR Honors</u>, was a member of the UNCTAD/UNEP Task Force developing a <u>methodology</u> for SDG indicator 12.6.1 and their guidance on core SDG indicators for business and was a member of WBCSD's working group on Governance. She is the academic lead for Common Ground Research Network's <u>Climate Change theme</u> and a Scientific Advisory Board member for <u>Scientist's Warning Foundation</u>. Victoria was a Director of a social enterprise, been a board member of a regional social enterprise group and is currently a Non-Executive Director of the organic standards company <u>Soil Association Certification</u> Ltd and FTB Lawsons Ltd. She has published research papers and thought pieces in journals including: Nature Climate Change, Energy Policy, The New Scientist and Sustainable Development.

## **Peter Young**

#### During this session:

Peter will use the example of the work of ISO's Sustainable Finance Committee (TC322) to show how ISO standards can help meet the demand for global alignment in the drive towards net zero. Peter will show how the many embedded ISO standards in the real economy can be utilised by the financial community, building towards a single global structure to support the transition of the financial ecosystem to sustainability.

#### Biography:

Peter Young chairs the International Organization for Standardization <u>Committee on Sustainable</u> <u>Finance (ISO/TC322)</u>, and the <u>Strategic Advisory Group for the BSI UK programme of sustainable</u> <u>finance standards</u>. He co-founded and chaired two third sector environment and sustainability organisations in the UK - the <u>Aldersgate Group</u>, and the <u>Broadway Initiative</u>. Peter is a trustee and former chair of the <u>Green Purposes Company</u> which safeguards the green purposes of the Green Investment Bank (now Group) under Macquarie's ownership. He is a member of the <u>Our Natural</u> <u>World Advisory Panel to Esmee Fairbairn</u>. Peter spent many years working internationally with businesses and governments on sustainability issues and lives in Scotland.
