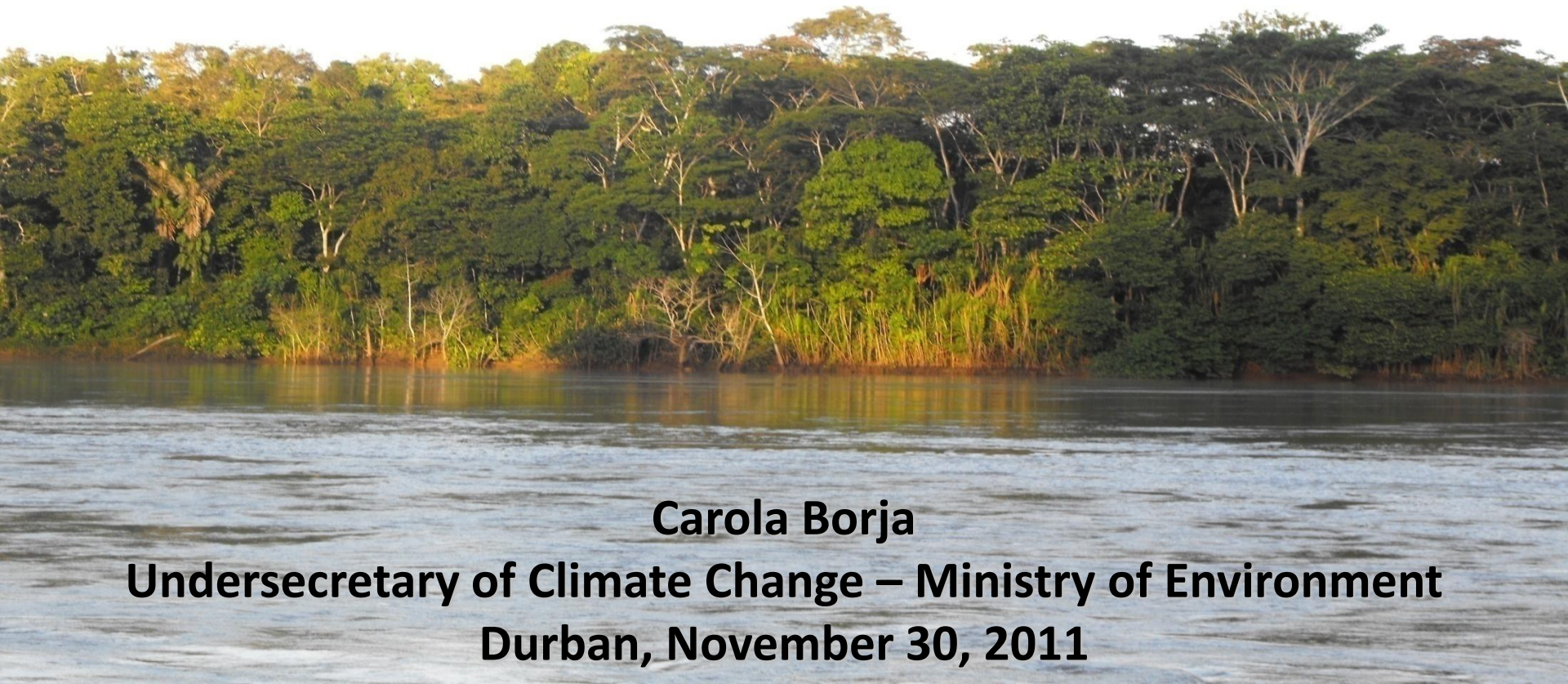

National interpretation process

NATIONAL INTERPRETATION WORKSHOP

- First national workshop with representatives of the public sector, CSOs and IPs
- National interpretation of the standards indicators to suit the national context
- Matrix of the national interpretation available for public comment in the Internet for a 90 day period



CONSULTATION WITH INDIGENOUS PEOPLES

- Two workshops with IPs' representatives to review the results of the national interpretation of indicators and receive their feedback
- Internet is not the appropriate tool



APPROVAL BY THE NATIONAL STANDARDS COMMITTEE

- Integration of comments received during the consultation process
- Revision by the Ministry of Environment to ensure alignment with the national legislation and maintaining the essence of the indicator
- Discussion and approval by the National Standards Committee

Work of the Committee so far

- 4 meetings and a workshop
- Revision and approval of the final version of the national interpretation

Monitoring and Assessment

Monitoring

- Develop a monitoring plan
 - Type and source of information to report on standards
 - Two parts: Socio Bosque Programme and National REDD+ Programme
- Piloting to Socio Bosque Programme
- Standards to be considered for the development of the National REDD+ Programme



Reporting and Assessment

- Final report in elaboration, to be completed with the results of the pilot implementation
- Review by stakeholders, the National Standards Committee and the facilitation team
- Ecuador's participation in sub-group to work with the International Secretariat on reviewing the principles and criteria

Challenges and Opportunities

Challenges

- ✓ Find a balance between participation and time and costs constraints
- ✓ Collecting and constantly update information on safeguards and REDD+ SES requires financial resources and technical capacities
- ✓ Review indicators to be merged or simplify so they are more easily monitored

Opportunities

- ✓ REDD+ SES as a useful tool to provide information for the safeguards information system
- ✓ Opportunity to build capacity and involve diverse stakeholders with some conflicting positions
- ✓ Stakeholder approach helps to strengthen information credibility and stakeholder empowerment of the reporting system
- ✓ Strengthen the relationship between CSOs, IPs and the Ministry of Environment

Ecuador : one of the 4 pilot countries

November 2011: First scoping workshop with representatives of the government, NGOs and IPs

- Road map to elaborate the '**Concept Note**' (Dec 11-Apr 12)
 - Interim working group (incl. members of the NSC)
 - National workshop to validate the concept note
- Opportunity for scaling up REDD+ SES to the PNREDD+ and feedback between the mechanisms

Social and Environmental Principles and Criteria

- Participation in the revision of the draft version of P&C
- Identify complementarity with REDD+ SES at conceptual level
- Harmonization with REDD+SES for implementation in Ecuador (as part of activities included in the NJP)

- ✓ Building a robust information system by concentrating efforts on information collection
- ✓ Integration of initiatives to ensure the cost-efficiency of the processes by using existing indicators and building on existing capacities in REDD+.
- ✓ Opportunity for feedback between mechanisms

Phase 3: planned activities

- Evaluation of phase 2 and lessons learned
 - Join indicators at national level
- Integration with PGA and P&C in practice:
 - Governance structures
 - Processes
 - Content
- Include REDD+ SES information to the national projects registry
- Scaling up the National REDD+ Programme
 - Ensure that the PNREDD+ include safeguards and REDD+ SES guidelines
 - Apply REDD+ SES to additional pilot REDD+ projects
 - Institutionalize the standards within the Ministry
 - Design and implement the national information system
