WBCSD Mission

- Provide business leadership as a catalyst for change towards sustainable development,
- Support business license to operate, innovate and grow in a world increasingly shaped by sustainable development issues.



The Mexican GHG Pilot Program

- Program MoU August 2004;
- Actual start December 2004;
- MoU with Det Norske Veritas (DNV) 2005;
- Is entirely voluntary;
- As of November 2005:
 - Phase I (establishing inventories) well underway;
 - ✓ 30+ companies participants;
 - ✓ Five groups established.



(Some) Key Program Features

- Voluntary: no direct financial incentives
- Local implementation (SEMARNAT + CESPEDES)
- Ensuring credibility/transparency:
 - Adheres to GHG Protocol reporting and verification principles;
 - Verification: voluntary but strongly encouraged; companies incentivised to opt for third party verification, provision of subsidized verification services.



What's in it for Business?

- Ability to translate "interest" to "experience";
- Demonstrate Business leadership: role of champions, effect of catalysts, on competitors + peer group;
- "Peer based learning";
- Doing it alone: costly, adopting best practice is tougher.



Key factors of success



 Clear Terms of Reference
 Common usage tools GHG Protocol – Corporate Standard and Project Accounting Business champion + peer engagement

Dedicated and efficient program facilitators



Business motivation: a key ingredient

- Mexican Businesses: similar drivers and business logic as other worldwide Businesses;
- Importance of "getting ahead of the curve":
 - to understand, measure and report their emissions
 to take action and initiate emissions reductions projects



Next steps?

- - Launch Phase II geographical + membership expansion
 - Emissions reduction projects
- "Duplication" of concept to other interested countries?
 - several ongoing initiatives,
 - Mexico's support, guidance and "return of experience" will be needed,
 - ✓ Support from international companies is key.
