BACKGROUND

UN Oceans is an inter-agency coordination mechanism that seeks to enhance the services provided to Member States by competent organizations of the United Nations system and the International Seabed Authority in relation to oceans, seas and coastal areas. It is mandated to strengthen and promote coordination and coherence of United Nations system activities related to ocean and coastal areas along with facilitating inter-agency information exchange, including sharing of experiences, best practices, tools and methodologies and lessons learned in ocean-related matters.

Under the ambit of the UN Oceans mandate, and at the beginning of the Decade of Ocean Science, the UN Oceans side event brings together representatives from member organisations to further inter-agency exchange with the overarching objective of raising ambition(s) on climate and the ocean, offering diverse perspectives and raising awareness about relevant activities within the UN system.

OBJECTIVES

As identified in the IPCC report on "The Ocean and Cryosphere in a Changing Climate", the ocean faces particular challenges both in relation to supporting mitigation goals and in adapting to the impacts of a warming climate. The objectives of the side event are to highlight ways in which UN Oceans Members can strengthen their synergies with a view to implement solutions to these challenges:

- Further the discussion on and implementation of science-based solutions to challenges facing climate and the ocean;
- In that context, discuss mitigation options; and
- Discuss adaptation options.
