11.30-13.00 **One Planet Fellowship: using a gender lens to invest in the next generation of climate adaptation scientists in Africa**

Organised by AWARD and the BNP Paribas Foundation

Africa is one of the most vulnerable continents to climate change and it is expected that the heaviest damages will be on the agriculture sector. Reductions in yield are projected to reach 50% by 2050, resulting in the agricultural production covering only 13% of populations needs.

By building a vibrant, intergenerational network of African & European scientists, the One Planet Fellowship Program hopes to deliver gender responsive climate adaptation solutions for African smallholder farmers.

This session aims to demonstrate that it is urgent to build such networks and the innovative approach that will be developed through the One Planet Fellowship Program.

16.30-18.00 **Protecting climate change investment**

Organised by the Permanent Court of Arbitration, the International Bar Association (IBA), the Arbitration Institute of the Stockholm Chamber of Commerce, and ICC.

This session aims to explore protection of the private and public-private investment in climate change mitigation and adaptation projects and programmes. In order to stimulate the necessary private investment required to implement the system transitions envisaged by the IPCC in its Special Report in October 2018, investors require regulatory and commercial certainty. On the regulatory front, states need to implement a binding regulatory framework to promote and govern system transition and investor conduct. On the contractual front, key contractual protections including international dispute resolution, such as conciliation and arbitration under the New York Convention on Enforcement of Arbitral Awards 1958, Investor State Dispute Settlement Convention (ICSID) and bilateral and multilateral investment treaties, provide a proven global framework that protects investment and state interests in a fair

and neutral manner that upholds the rule of law and contractual certainty. The panel will consider the strengths and weaknesses of this existing framework – and potential improvements – in protecting climate change investments and enhancing and promoting private investment in system transition.
