ABSTRACT

As the first GST is to be concluded at COP28, one important consideration is the involvement of Non-State Actors (NSAs) in the post-GST activities. The independent Global Stocktake (iGST) Regional Hubs in Southeast Asia and West Africa have been working actively to contribute to the first GST processes including submission of inputs based on regional assessments and participation in technical discussion of inputs. In this session, we aim to explore the ways in which NSAs and state actors can effectively collaborate and align their efforts during the post-stage of this first GST to have more ambitious climate action at the next round of nationally determined contributions (NDCs).
