Adaptation to Climate Change - Integration into Development Planning

Multi-stakeholder processes for developing climate change adaptation strategies and mainstreaming adaptation into national and local development planning - first experiences and lessons learnt from country cases from the **Philippines**, **Tunisia**, **Peru and Germany**

Background

The central climate policy objective discussed under UNFCCC is to limit the increase in the mean global temperature to less than 2°C above the pre-industrial level, with the aim of preventing the expected far-reaching consequences of even greater climate change. However, even with successful efforts to limit temperature rise, climate change is already taking place and will have serious effects on countries, their economies and population. Therefore, besides putting all efforts into mitigation of greenhouse gas emissions, there is high urgency to develop adaptation strategies to reduce the vulnerability of countries for social, ecological and economic disasters caused by global warming and to mitigate the expected impacts of climate change.

Some countries have already started to develop their national adaptation strategies or national climate change action plans. The side event will outline some of the approaches, experiences and lessons learnt with specific focus on how adaptation to climate change can be integrated into national and local planning and budgeting processes. It will provide a platform for discussion of key success factors, and for exchange and transfer of knowledge between countries dealing with adaptation to climate change in various settings.
