


### About ICLEI

# Local Government Perspective on Loss and Damage

- Local communities are already experiencing loss and damage – climate change will worsen this
- Should focus on all communities not just urban, large, or developing (i.e. peri-urban, agricultural)
- Focus on combating loss and damages through building resilience - ecosystem protection, economic development, poverty eradication

# Local Government Perspective on Loss and Damage

Insurance – needs to reward those progressive communities that are building resilience – not subsidize poor development strategies or inaction

Resilience building, adaptation and disaster risk reduction will reduce exposure - of communities and of insurers

### The Emerging ICLEI Approach

2011 Bonn Declaration of Mayors

1 Efforts on urban resilience and adaptation should shift from a singular, special purpose focus on specific climateaffected infrastructure and locations towards a more integrated focus on overall risks, development conditions, and local area performance
