effective implementation




Liberia's National Context



- Population: 3.2 million
- Gross National Income: US\$140 per capita
- Forest area: 45%
- Illiteracy rate 85%
- Agricultural workforce 85%
- Passed Poverty Reduction Strategy for 2009-2011



Government Organization



EPA Goal: To Provide leadership in spearheading emission trading in an environmental field of business in Liberia



Liberia's REDD Capacity Status

- Rapidly rebuilding capacity and forest governance after the civil conflict
- Need to build both national and field capacity quickly and in parallel
 - Across all government agencies
 - Growing civil society capacity
 - With international support of partners



Liberia's Technical Capacity

- Completed national forest change updates to 2006
- Established national monitoring plot network

• Technical capacity needs:

- Full forest inventory
- Projected modelling of future emissions
- Deforestation driver and actor analysis
- Monitoring and evaluation procedures
- South-south exchanges on remote sensing
- Address degradation needs



Liberia's Institutional Capacity

- Created Liberia Forest Initiative (LFI) with a diverse consortium
- Implementing FDA and EPA strengthening
- Develop full functional Designated National Authority within the EPA
- Build economic analyses of alternatives to enable crossministerial consensus on REDD
- Dramatically increase field capacity of government and civil society for demonstration activities
- Coordinate with land tenure clarification processes
- Reduce low-production shifting cultivation by promoting integrated agriculture
- Implement chain of custody & sustainable forest management



Liberia's Stakeholder Engagement

- Completed stakeholder process for Forestry Reform Law of 2006
- Develop climate change public awareness and training particularly for demonstration activities and equitable benefits sharing
- Increase local community understanding
- Test and implement community-based forestry plans



Take Home Messages

- Liberia holds great potential for national level REDD implementation assuming that:
 - REDD negotiations clarify steps forward
 - Adequate funding for capacity is provided
 - Potential for 'early action' incentives are realized
- Liberia has made significant progress preparing for REDD through forest policy and governance reforms
- Demonstration initiatives need to be designed to directly address threats to deforestation and ensure that benefits are equitably shared with local communities
