

Sustainable development

- UNFCCC study of sustainable development impact, technology transfer, and financial flows.
- Based on analysis of claims in 3,276 CDM project design documents compared with results from a survey of project proponents and results from other published research.

BENEFITS OF THE CLEAN DEVELOPMENT MECHANISM 2011



Sustainable development

- Investment in CDM projects to mid 2011 over \$140 billion
- Average mitigation cost US\$ 2-10/tonne CO2 eq.
- Very likely that mitigation exceeds CER issued (project life time exceeds crediting period)





Sustainable development

- 80% of PDD claims correlate to survey results. Still weak overall correlation
- Lack of SD definition and common indicators impeded verifying benefits
- Technology transfer can be identified with high degree of certainty, in particular in more advanced developing countries.





>2.7 billion CERs estimated in pipeline; >1 billion to be issued to end of 2012




