#### Putting community at the center of development: Climate-friendly, forest-based livelihoods

Organizer: Asia Pulp & Paper Group (APP)

This session, hosted by APP, features a discussion of APP's community engagement approach, which aims to support the Government of Indonesia's priority development agenda (Nawa Cita) and the Sustainable Development Goals through the implementation of Free, Prior and Informed Consent, the responsible resolution of conflicts, as well as improving community welfare through the implementation of a sustainable community-based business model.

Speakers will share their experiences regarding the processes of establishing new institutions, the cost of creating and managing the pilot projects, and provide an evaluation of the impact of REDD+ on deforestation and livelihoods. Findings will be shared with researchers, policy makers and civil society.

## Social forestry sustains local actions to advance the Paris Agreement
