Speaker Biographies

Jessica Bowman is the Executive Director of the <u>Plant Based Products Council</u> and Vice President of Advanced Bioproducts for the <u>Corn Refiners Association</u>. She was previously employed by the American Chemistry Council where she served as Executive Director of the FluoroCouncil. Prior to that, she was Senior Director of Environmental Affairs at Airports Council International-North America. Jessica earned her juris doctor from the University of Maryland School of Law and a Bachelor of Science degree in GeoEnvironmental Engineering from the Pennsylvania State University.

Lisa Jacobson is the President of the <u>Business Council for Sustainable Energy</u>, a 55-member trade association representing the energy efficiency, renewable energy and natural gas industries. Ms. Jacobson has advised states and federal policymakers on energy, tax, air quality and climate change issues. She is a member of the U.S. Department of Energy's State Energy Efficiency steering committee and the United States Trade Representative's Trade and Environment Policy Advisory Committee.

John Kadyszewski is the Senior Advisor, <u>Architecture for REDD+ Transactions (ART)</u>, Senior Director for Strategic Initiatives at Winrock International and the Director for its <u>American Carbon Registry (ACR)</u>. During his time as Director, ACR has pioneered multiple methodologies and issued more than 100 million tons of emissions reductions with a market value in excess of one billion dollars. He continues to work on other Winrock strategic initiatives and currently serves as the Senior Advisor for the newly launched <u>Architecture for REDD+ Transactions (ART)</u> that seeks to mobilize capital for investment to stop global deforestation and forest degradation.

Lisa Manley is Senior Director, Sustainability at Mars, Incorporated, which she joined in April of 2017 bringing nearly twenty years of experience in sustainability communications, partnerships and policy engagement to the team. She's worked in-house at The Coca-Cola Company in the United States and Europe and served as a consultant to numerous Fortune 100 companies – always focused on integrating social and environmental sustainability in to business strategy. Lisa has helped shape globally recognized initiatives on climate action, water stewardship, sustainable packaging and unlocking opportunities for women.

Laura Van Wie McGrory is the Vice President of Strategic Initiatives at the Alliance to Save Energy.
