Short bio on the speakers: Silje Lundberg, OCI

Robin Averbeck is Rainforest Action Network's Forest Program Director and has 15 years of experience working on international forests and social justice campaigns. They have worked in RAN's Forests program for over 10 years on its Conflict Palm Oil and Rainforest Free Paper campaigns and now as the Forest Program Director. Together with RAN's team, Robin has led corporate campaigns and negotiations targeting the biggest actors driving Indonesian deforestation, climate change and human and labor rights abuses.

Daniel T'seleie - Indigenous Climate Action

Daniel T'seleie is K'ahsho Got'ine Dene from Radili Ko (aka Fort Good Hope, Northwest Territories), which is an isolated Arctic community that is experiencing severe impacts of climate change. He is on ICA's steering committee, and has been advocating for climate justice and an end to fossil fuel extraction for the past decade. Daniel is also a student trainer of non-violent direct action, a former lawyer, and Chief Negotiator for his nation's self-government discussions with the Canadian state.

Babawale Obayanju - ERA

Babawale (Wale) Obayanju is a Nigerian who lives and works amongst the people of the Niger Delta Region. He is a climate justice campaigner working with peoples of the region. Wale works with digital media especially photography and films to shed light on the issues in the region. He works with Environmental Rights Action and is a co host of TellThatStory, a collective of creatives who highlight and proffer solutions (where possible) to issues befalling Mother Earth (www.tellthatstory.com.ng)

Minister Andrea Meza Murillo

Minister Andrea Meza was the **Director of Climate Change for Costa Rica** since 2015, where she directed the formulation and implementation of the National Decarbonization Plan with a view to eliminate Costa Rica's reliance on fossil fuels by 2050. She is now the Minister of Environment and Energy of Costa Rica, and co-chair for the Beyond Oil and Gas Alliance

Alex Rafalowicz - Treaty initiative

Alex Rafalowicz is the Global Director for the Fossil Fuel Non Proliferation treaty Initiative. He has worked as a policy analyst, campaigner, organiser and strategist for climate justice for 15 years including with the Global Campaign to Demand Climate Justice, the Climate Action Network, and 350.org.
