What is the event about?

The transport sector is responsible for 23% of global energy-related CO_2 emissions and in many countries GHG emissions from transport are growing faster than from other sectors. However, the CDM merely tapped the mitigation potential of the sector; will Nationally Appropriate Mitigation Actions (NAMAs) deliver?

The Symposium builds on the results of the first SLOCAT-Bridging the Gap Working Group on transport NAMAs that was held in Seoul, Republic of Korea, on the 12th and 13th of April, 2011. In doing so, the event will present the latest developments on transport NAMAs and discuss these with governmental representatives and world leading experts in the field:

- What is needed to make the concept of NAMAs work for the transport sector? Which lessons need to be learned from the experience with the CDM?
- How could transport NAMAs and MRV of emission reductions look in practice?
- How could international support (financing, capacity building and technology transfer) be matched with the development and implementation of transport NAMAs?

Who is Bridging the Gap?

To encourage international action and to slow growth in GHG emissions, GIZ, Veolia Transdev, ITDP, UITP and TRL have joined forces to encourage recognition that transport can and should play an important role in mitigating GHG emissions. Together we hope to achieve a post-2012 agreement that will help to achieve a sustainable land transport sector.



The venue is located in close proximity to the Maritim Hotel, the location of the Bonn climate talks. It can be reached on foot from the tram stops: "Max-Löbner-Straße, "Robert-Schuman-Platz," and "Deutsche Telekom/Platz der Vereinten Nationen" (see map below).





By public transport:

If you are travelling from Bonn central station you can reach the conference venue, GSI, via U-Bahn lines 16 and 63, which run approximately every seven minutes between Bonn central station and Bad Godesberg. Alight at the stop "Max-Löbner-Straβe." From here, walk down "Max-Löbner-Straβe" and you will find the conference venue at the end of this road.

If you are travelling from the ICE-station Sieburg/Bonn then you can reach the conference venue via U-Bahn line 66 in the direction of Bonn/Bad Honnef. Alight at the stop "Robert-Schuman-Platz" and from here walk down Kurt-Georg-Kiesinger-Allee before turning left into Jean-Monet-Straβe, then left into Heinemann-Straβe.

By plane:

From Cologne/Bonn airport take the Airport bus SB 60 to Bonn Central Station (Hauptbahnhof) and then follow the public transport directions provided above.
