Björn STIGSON

**President, WORLD BUSINESS COUNCIL FOR SUSTAINABLE DEVELOPMENT

Björn Stigson has been President of the World Business Council for Sustainable Development (WBCSD), a coalition of some 200 leading international corporations, since 1995. He also serves on the boards of committees advising the Chinese government, the Dow Jones Sustainability Indexes, the Kennedy School of Government at Harvard University, the Clinton Global Initiative and the Global Reporting Initiative.

Mr Stigson began his career as financial analyst with the Swedish Kockums Group. From 1971-82, he worked for ESAB, an international supplier of welding equipment, where he was responsible for finance, operations and marketing. In 1983 he became President and CEO of the environmental control technology company Fläkt Group. Following the acquisition of Fläkt by ABB, in 1991 he became Executive Vice President and a member of ABB Asea Brown Boveri's Executive Management Group. From 1993-94 Mr Stigson ran his own management consultancy.

Lewis Fulton is a senior transport energy specialist at the International Energy Agency and has been working in the areas of transport and energy for more than 20 years overall.

He was involved in developing and implementing sustainable transport projects around the world with the UN Environment Programme in 2006 and 2007, leveraging funding from the Global Environment Facility (GEF). His IEA reports have dealt with transport, energy and CO2 issues, including in particular fuels and biofuels and future bus systems. Before, Mr Fulton has worked at the U.S. Department of Energy (1992-1996) and at the Independent University in Bangladesh (1996-1997).

Rajendra Pachauri has been elected as Chairman of the Intergovernmental Panel on Climate Change in 2002. The IPCC was established by the World Meteorological Organization and the United Nations Environment Programme in 1988. Mr Pachauri has been active in several international forums dealing with the subject of climate change and its policy dimensions.

Mr Pachauri has also been heading TERI, the Indian Tata Energy Research Institute since 1981, first as Director and, since April 2001, as Director-General. TERI provides advice in the areas of energy, environment, forestry, biotechnology, and the conservation of natural resources to government departments, institutions, and corporate organizations worldwide.

Mr Pachauri holds a degree and PhD in industrial engineering and a PhD in economics.
