As of November 1, 2010 NEIA's electronic data base lists 184 JI projects that have received Letters of Endorsement. Estimated GHG emission reductions during the first commitment period of the Kyoto Protocol under these JI projects are 171,8 million tones CO2 eq. The number of JI projects by sectors/source categories and estimated GHG emission reductions by sectors/source categories during the first commitment period of the Kyoto Protocol are represented in following diagrams.

At the moment there are 56 JI projects out of 184 that had developed PDDs, passed through determination procedure and were issued Letters of Approval. Estimated GHG emission reductions during the first commitment period of the Kyoto Protocol under these JI projects are 82,6 million tones CO2 eq.

During 2008-2010 19 JI projects have been deemed final by the NEIA under Track 1 and 13 JI projects by Track 2. According to project owner's requests and subject to registered documents, NEIA had carried out electronic transactions to foreign buyers in the amount of 21 820 940 carbon units (among them 9 027 943 AAUs and 12 792 997 ERUs) under 23 JI projects. At the moment there are about 26 million of ERUs issued in the world. Thus almost 50 % of all ERUs are of Ukrainian origin.
