3. Overview of application process

The below table represents a general overview of the application process. For exact deadlines of each particular session, please refer to the timeline published on the <u>home page of SEORS</u>.



Only one application for a side event and one application for an exhibit can be submitted for a particularUNFCCC session per Party or observer organization, regardless if it is as a single application or part of a joint application.

4. Application steps

4.1 Prepare your proposal

You will have to provide the following information for your application. The information can be preliminary and updated at a later point. For side events, updates are possibleup until two days before the side event takes place.

<u>N.B.</u> : Comments entered into this field are automatically transferred to the communication log (which can be accessed through the link "Communicate with the secretariat") once thedraft is saved. They do not appear on the application form if the draft is opened again. It is not necessary to re-enter your comments on the form.		

4.2 Start your application in SEORS

To start your application in SEORS, you have to click on the **"Apply"** button indicating the conference that you are applying for. You can reach the apply button either via the home page of SEORS or by clicking on the conference title in the left-handside menu on the <u>home page of SEORS</u>.



Please note that the **"Apply"** appears on the home page of SEORS <u>only during the application period</u>. Therefore, it is not possible to register in SEORS ahead of the application period.

Once the official registration period has concluded, it will only be possible to apply for being placed on the waiting list by clicking on the "Apply to be on the waiting list" button on the home page of SEORS. For more information on the waiting list, please consult section 10 of the current manual

N.B.!

You must create a new personal account in SEORS by clicking on the "Apply" button for each conference. Your user name and password from the previous conferences do not work.

4.3 Select your observer organization/Party

Once you have clicked on the **"Apply"** button on the home page of SEORS, you will be transferred to the account creation page on which you will be asked to select your observer organization/Party and enter your contact details.

4.5 Log in to your SEORS personal account

After completing the registration, you will receive an email with your login and password with the following subject line: **"UNFCCC: Login details for your SEORS account".**



Please follow the link provided in the automated email in order to log into your personal account.

Throughout the entire process SEORS will send you important messages and sometimes they might be categorized as spam by your email provider. Remember to always check your email filters and spam box. Therefore, it is also highly recommended that <u>see@unfccc.int</u> be added to your trusted contacts list to minimize communication issues. Alternatively, you may click on "Click here to login" at the top of the SEORS homepage:



- Please be reminded that your username and password are <u>case-sensitive</u>.
- In case you copy your username and/or your password from the email, please be reminded that the email client could be adding an extra space at the end. Please make sure that you are only copying the right characters.
- ✓ You can change your password in SEORS once you have logged in for the first time.

When entering the details of your application, please pay attention to the following:

- ✓ There are strict character limits for each section (title, theme, speakers) in SEORS. You will not be able to upload a text exceeding the indicated character limits.
- ✓ Some fields are mandatory. You will not be able to submit your application unless you have provided all the mandatory information.

4.7 Request Focal Point authorization

Your application can only be considered by the secretariat if it is authorized by your Focal Point. Please note that there is no "Submit" button in SEORS. In order to submit your application, you have to click on the **"Request authorization from your NFP/DCP"** button in your personal account in SEORS.

After you have entered your application details, your application will appear in a text box in your personal account. In the **"Action"** column of this box you will find a link to automatically **"Request authorization"** from yourFocal Point.

Once you have clicked on the **"Request authorization"** button, your Focal Point will receive an automated message that asks for authorization or turndown (see example below).

Dear National Focal Point/Designated Contact Point,
Please note that due to space constraints ONLY ONE APPLICATION per Party/IGO or NGO may be considered by the secretariat. Therefore the Side Events and Exhibits Online Registration System (SEORS) has been technically modified to only allow you to authorize one application.
In order to have a clear overview of all applications from your Party/observer organization we suggest that you authorize your preferred application after SEORS is closed for applications. Thank you for your cooperation.

N.B.!

Your Focal Point does not need to have an account in SEORS or to register in SEORS to authorize your application. They will be automatically redirected to the authorization page by clicking on the link in the automated email from SEORS.

It is possible to authorize <u>only one side event application</u> and <u>only one exhibit application</u> per observer organization/Party.

You can find the names of all the Designated Contact Points (DCPs) on the following pages on the official UNFCCC website:

- for admitted NGOs;
- for admitted IGOs.

Please note that the webpages above can be used to check the <u>names</u> of the DCPs and do not necessarily list their personal email addresses to which authorization requests get sent from SEORS. Please note that it is the responsibility of the applicant to follow up with their DCP/NFP.

If your application receives authorization by your Focal Point it moves to "negotiation" stage (status is updated accordingly).

Only applications in "negotiation" stage will be considered by the secretariat. Those applications which were turned down by the Focal Points will move back to "draft" stage and cannot be considered by the secretariat.

5. Joint applications

5.1 Key rules on joint applications

- a) Each partner in a joint application must be eligible and must submit a separate application in SEORS during the official application period. The submission of "pre-merged" applications is not allowed by the system.
- b) Each joint application must have one, and only one, lead applicant;
- c) Each joint application may have more than one co-applicant;
- d) Each application may be part of only one joint application;
- e) Only applications in "negotiation" stage (i.e. authorized by applicant's Focal Point) can merge into a joint application;
- f) Any consolidation (merging) of applicants must be finalized before the deadline set and communicated by the secretariat.



Please be reminded that Parties <u>must partner with observers</u> for their applications to be considered by the secretariat. Those Party applications which have not been duly merged with at least one observer organization in SEORS will be declined by the secretariat. However, **SEORS does not allow for the submission of pre-merged applications**. Therefore, for those applicants applying on behalf of Parties, it is necessary to firstly submit a separate application and duly merge it in SEORS with at least one observer organization following the instructions outlined in the current section.

5.2 Find potential partners

Once your application is authorized by your Focal Point, a **"Merge"** button appears in the **"Action"** column of your personal SEORS account. After clinking on this button, you can access the list of all applications received within the application period and authorized by the relevant Focal Points.

If you identify an application or applications that you wish to consolidate your application with, please first contact the applicant via email or phone. Once a consolidation has been agreed on and a lead applicant has been identified, you can proceed to merging of your applications in your SEORS account.

5.3 Implement the consolidation of applications in SEORS

Click on the **"Merge"** link in the **"Action"** column of your application to see the list of all applications in "Negotiation" stage. Then clink on a **"Request merger"** link in front of the application of your partner. You may either select **"Merge as lead applicant"** or **"Merge as co-applicant"**. If a prior agreement was reached that you will be the lead applicant of the joint application, please click on **"Merge as lead applicant"** in the field of your partner's application. If you have agreed to merge as a co-applicant, pleaseclick on **"Merge as co-applicant"** in the field of your partner's application.

- If you merge your application as the lead applicant, your individual application will serve as your joint application. The content of your co-applicants' individual applications will be disregarded starting from the moment your merger gets registered in the system. You will be able to update the content of your joint application after the merger in your personal account in SEORS. (For more information on how to update your application, please refer to section 5.9).
- If you merge your application as a co-applicant, your individual application will be disregarded starting from the moment your merger gets registered in the system. Your lead applicant's application will serve as your joint application. In order to update the content of your joint application, please liaise with the lead applicant.

Your partner will then automatically receive your merger request(s) by email. Once they accept your merger request, the consolidation (merger) of your applications is finalized.

Example: Applicants A, B and C have agreed via email and/or telephone to consolidate their applications with A as lead applicant and B and C as co-applicants. In order to reflect these joint efforts in SEORS, applicant B and applicant C log into their personal SEORS account and click on "Merge" in the "Action" column of their application overview. In a second step, they click "Merge as co-applicant" in the "Action" column of applicant A's application. Applicant A will receive two automated requests to confirm the merger with B and C respectively. Upon confirmation by applicant A, the consolidation will be reflected in SEORS. Alternatively, applicant A can send merger requests as a lead to applicant B and applicant C. In this case, the consolidation will be effective once the merger requests are accepted by applicant B and applicant C.

In case your potential partner accepts a merger request from another applicant that conflicts with yourmerger proposal (e.g. by creating two leads for the same joint application), your merger request will disappear from your SEORS account. The same happens to your partner's merger request if he/she lateraccepted the proposal from another applicant that conflicts with a merger with you.

Example: Applicant A proposes to applicant B a merger where A would be the lead, but in the meantime, B accepts a merger proposal from applicant C where C is the lead. Since B can be a co-applicant in only one joint application, the merger request from A cannot be fulfilled. It is however still possible for A to send a merger request to C as the lead of B/C joint application. If A sends the merger request as lead and C accepts it, the leadership in the joint A/B/C application is passed on to A.

5.6 Responsibilities of the lead applicant

The lead applicant acts as the main contact point for the joint application toward the secretariat:

- Communication from the secretariat is sent to the lead applicant, who is responsible to pass the information on to the co-applicants;
- Only the lead applicant can edit the application and upload attachments to the SEORS schedule (in the event that the application is selected and allocated by the secretariat). For Instructions on how to add an attachment to the SEORS schedule, see section 8 of the current manual.

N.B.!

After your merger has been registered in the system, the lead applicant becomes the main contact point for your joint application. Please note that no further communication is being sent to co-applicants after the merger. It is the responsibility of the lead applicant to pass the information they receive from the secretariat to co-applicants.

5.7 Change the lead applicant

If needed, it is possible to change the lead applicant if the consolidation period is still open. To implement the change, all co-applicants need to **"Unmerge"** their applications from the current lead applicant (see section 5.8 for more details on "unmerging") and then proceed to the merger again with the newly agreed lead applicant.

N.B.! Please note that it is necessary that co-applicants unmerge their applications from the joint application first. The lead applicant cannot leave the joint application without co-applicants unmerging their applications first.

5.8 "Unmerge" your consolidated application

If you are a co-applicant of a joint application, you can separate your application by clicking on the **"Unmerge"** button in the **"Action"** column of the application overview in your personal account:

- After mergers, the lead applicant is responsible for updating the joint application via their personal SEORS account.
- For co-applicants, it is not necessary to update their individual application in SEORS as it will not be considered by the secretariat. If they wish to update their joint application, they should liaise with the lead applicant and ask them to update the joint application.

After the merger period has concluded, the secretariat communicates the date beyond which no direct editing is possible in SEORS. **N.B.! It is important that you duly update your application before the secretariat downloads applications from SEORS for the evaluation. The secretariat communicates the deadline to update applications via the SEORS communication log.**

Any further changes in your application's title/description/list of speakers will need to be communicated to the secretariat through the SEORS communication log of the lead applicant. The primary thematic category cannot be changed as this is factored in the selection and allocation. We kindly ask all applicants to finish editing their applications before the start of the conference.

Please note that there is no guarantee that we will be able to reflect the changes in the SEORS schedule if they are communicated to us less than 48 hours prior to the start of the side event.

5.10 Visibility of joint application on public web schedule

If your merged application is successfully selected and allocated, its description appearson the SEORS public web schedule. All the official organizers of the side event/exhibit are listed there, the lead organizer being listed first.



6. Communicating with the secretariat

Please use the **"Communicate"** function in the **"Action"** column of your personal SEORS account to communicate with the secretariat on any issues regarding your application. A communication log will be kept in your personal account for your reference. Due to the high number of applications the communication log serves as an ideal channel to keep all information in one place.

7. Selection and allocation

After the consolidation deadline, the secretariat will begin selection and allocation of the eligible applications and aim to complete the confirmation by approximately one month prior to the conference. The secretariat may have to decline some of the applications due to space constraint at the venue. An automated message will be sent to the applicants informing them that their application has been selected or declined. **Once the confirmation is made, you can no longer edit the details in SEORS yourself.** Changes to the title, theme or speakers have to be communicated to the secretariat in order to be implemented. Please note that the primary thematic category cannot be changed as this is factored in the selection and allocation.

If you wish to change the confirmed date or time, please seek at your own initiative an organizer who agrees to swap slots with you and inform the secretariat accordingly of such a proposed swap through SEORS. The secretariat will thereafter decide whether this is acceptable, subject to the prevailing criteria, and inform you accordingly.

8. Uploading attachments to the web schedule

If your application is selected for allocation you will be able to upload information pertaining to your side event/exhibit to the UNFCCC website. Please use the upload function in your personal account for this purpose.

10.Waiting list

The secretariat communicates the application timeline on the <u>home page of SEORS</u> and by sending a notification to Parties and observers ahead of the conference. Once the official registration period has concluded, it is only possible to submit a side event and/or an exhibit application for being placed on the waiting list. Please be informed that there is no guarantee that your waiting list application will be confirmed by the secretariat. Applicants on the waiting list will be contacted in case of cancellations by selected side event organizers/exhibitors.

In case you have missed the application deadline, you can submit your side event and/or exhibit application for being placed on the waiting list by clicking on the **"Apply for being placed on the waiting list [Name of the session]"** button on the home page of SEORS:
